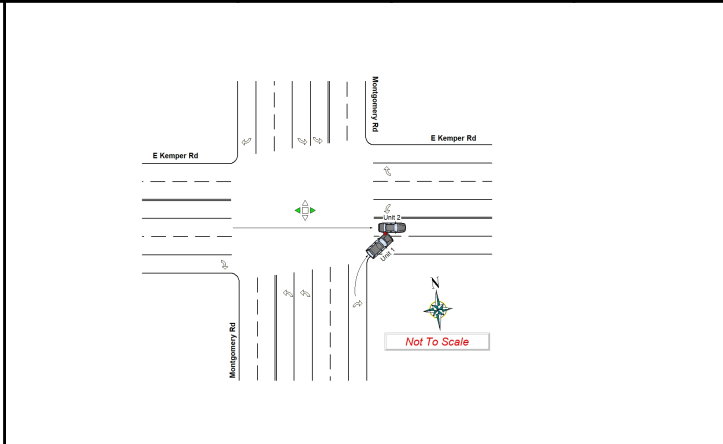

NARRATIVE
 UNIT 2 WAS TRAVELING EAST ON E KEMPER RD IN THE LEFT STRAIGHT-ONLY LANE, PROCEEDING THROUGH THE INTERSECTION OF E KEMPER RD AND MONTGOMERY RD. UNIT 1 WAS TRAVELING NORTHEAST ON MONTGOMERY RD, APPROACHING E KEMPER RD IN THE RIGHT TURN-ONLY LANE. UNIT 1 APPROACHED A RED LIGHT AND STOPPED. AFTER UNIT 1 CAME TO A STOP, UNIT 1 PROCEEDED TO TURN RIGHT ON RED ONTO E KEMPER RD, AND INTO THE LEFT LANE. AS UNIT 1 TURNED RIGHT INTO THE LEFT LANE, IT ENTERED UNIT 2'S PATH, STRIKING UNIT 2. UNIT 1'S OPERATOR WAS CITED FOR IMPROPER TURN (4511.36 ORC). NO INJURIES WERE REPORTED AT THE SCENE.

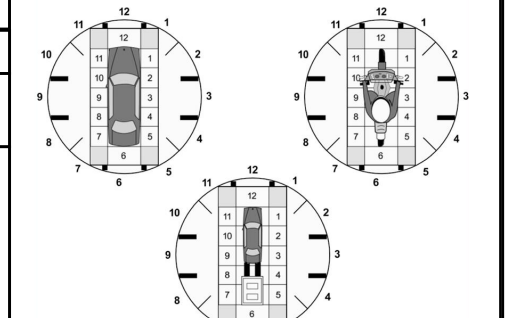

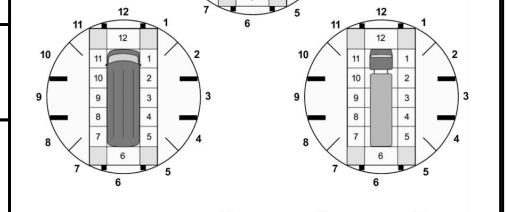

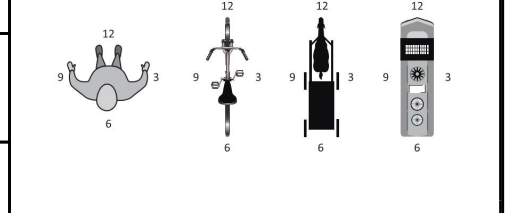
